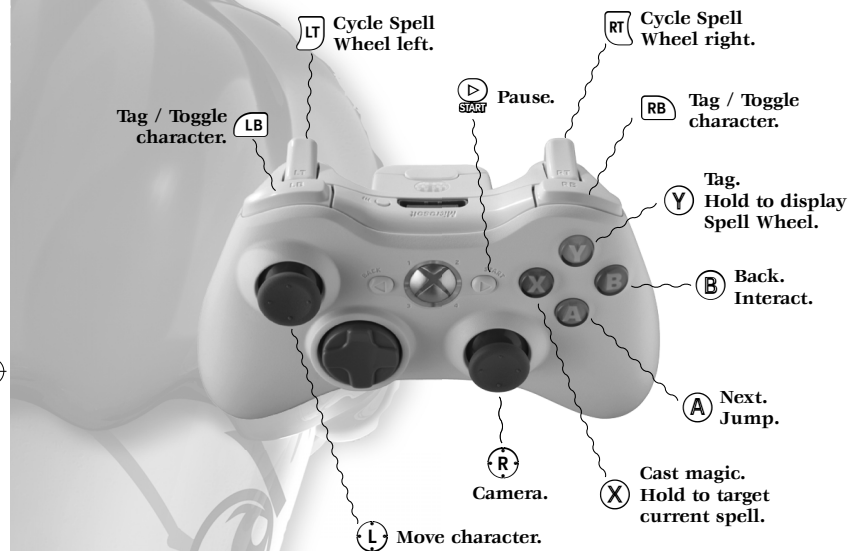

RED BRICKS

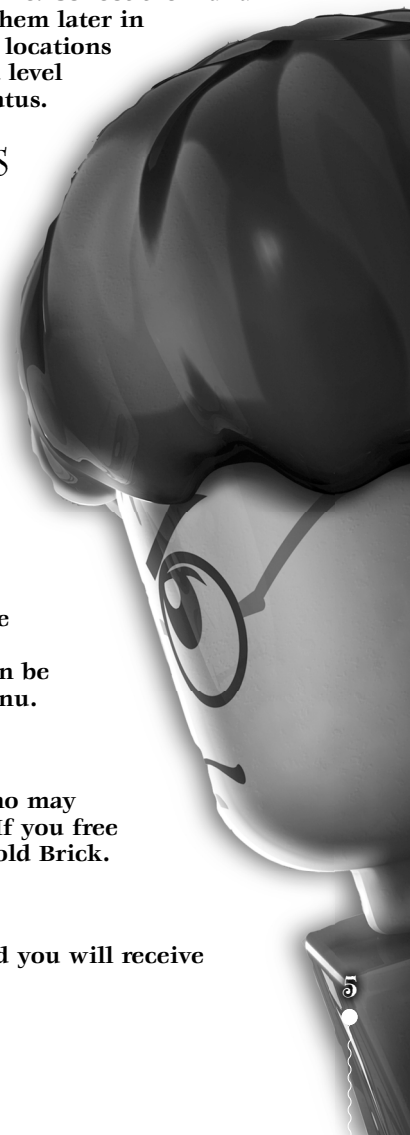
Find a Red Brick to make it available for purchase in Diagon Alley. Once found and purchased, Red Bricks can be activated in Extras via the Pause menu.
